Arizona Department of Emergency and Military Affairs Tribal Consultation Annual Report July 1, 2018 – June 30, 2019

Agency Overview

The Department of Emergency and Military Affairs (DEMA) consists of the Army National Guard, the Air National Guard, the Division of Emergency Management (ADEM), the Division of Administrative Services, and the Joint Task Force. DEMA provides unique capabilities and services to the citizens of Arizona in three distinct roles: community, state and federal.

Tribal Consultation Policy

DEMA recognizes and honors the Government-to-Government relationship that exists between the State of Arizona and the Tribes. To that end, the Department created its first "Tribal Consultation Policy" in 2006, as part of Executive Order 2006-14, "Consultation and Cooperation with Arizona Tribes" and continues it today in compliance with Arizona Revised Statutes (A.R.S.) §41-2051 Section C. The Adjutant General, Major General Michael T. McGuire, on November 15, 2018, signed an updated "Tribal Consultation Policy" Policy Letter No. 10.20. This updated policy letter was disseminated internally, sent externally to the Governor's Office on Tribal Relations, and was shared with all of the Tribal Emergency Managers.

Tribal Liaison

DEMA met the obligation of having a dedicated Tribal Point-of-Contact (POC) when it created the Tribal Liaison position, as a necessary extension of Executive Order 2006-14. This position currently reports to the Adjutant General and the Director of Administrative Services, works closely with the Deputy Director of the Department of Emergency Management, and provides direct access between the tribes and DEMA. The Tribal Liaison advises DEMA staff on tribal related issues to include cultural awareness and sensitivity.

FY19 Tribal Consultation Activities

DEMA continued to work collaboratively and in partnership with Tribes in Arizona in compliance with A.R.S. §41-2051 Section C. To that end, DEMA conducted and/or participated in various activities throughout the past year with the intent to support Tribal efforts in increasing their emergency management capabilities. This has included providing a number of training opportunities, requesting Tribal participation in exercises including the 2019 PVGS Plume Phase Full-Scale Exercise, and supporting Tribes with their exercises. These exercises included the Navajo Nation's Operation Jinii Functional Exercise and the Gila River Indian Community's Annual Tabletop Exercise. DEMA continued to engage in information sharing with Tribal partners on a regular basis via various mechanisms including face-to-face meetings with Tribal Emergency Managers on Tribal lands, hosting quarterly meetings with Tribal and County Emergency Managers in its northern, central, and southern Regions, and through the DEMA Tribal Emergency Management Summit which was held in September 2018 focusing on "Supporting Tribal Emergency Management Response". DEMA continued to provide tribes with a number of public information resources including disaster campaign materials that covered various hazards. These materials allow Tribes to use, revise, and develop them in order to meet their Tribe-specific needs which include continued support for the statewide "Monsoon Awareness" campaign and the "Ready-Set, Go!" program that supports evacuations as the result of an emergency.

The DEMA Tribal Liaison also supported various agencies at the state and federal level with their efforts to work with and collaborate with the Tribes in relation to emergency management. This included supporting the Federal Emergency Management Agency (FEMA) in their efforts to complete the FEMA Region IX Tribal Emergency Communications Annex, the Department of Public Safety (DPS) with communication issues on the Tohono O'odham Nation, and the Arizona Geological Survey in attaining Tribal participation in their Arizona ShakeOut Annual Statewide Earthquake Drill. The following table provides an overview of related activities:

Highlights

The DEMA Tribal Liaison continues to support engagement between the Tribes and other State agencies, Federal partners, and Volunteer Organizations Active in Disasters (VOADs) before, during, and after incidents on their lands. This resulted in the DEMA Tribal Liaison being been asked to speak about tribal engagement at various events including the HHS National Institute of Environmental Health Sciences Listening Sessions and the University of Arizona's Tribal Forum "Disaster Response on Tribal Lands".

Recommendations from Tribal Representatives

The Tribal Liaison has been asked to help deconflict the various meetings that the Tribes are asked to attend with various State agencies and the Inter-Tribal Council of Arizona (ITCA). The Tribal Liaison will work with these entities to create a calendar of events to help minimize meeting conflicts.
