TRIBAL CONSULTATION ANNUAL REPORT July 1, 2018 – June 30, 2019

Agency Overview

Purpose:

The Arizona Department of Economic Security (DES or Department) works to strengthen and build strong relationships with Arizona's 22 Tribes. The Department is committed to working with American Indian Tribes to improve the quality, availability, and accessibility of human services to children, youth, and adults. The Department's Tribal Government Consultation policy ensures that DES engages in *open, continuous, meaningful communication, and consultation* with the 22 Arizona Tribal Nation. This consists of information exchange and mutual understanding prior to taking actions that will likely have a direct impact on the American Indian Tribes in Arizona.

Office of Tribal Relations Team:

To ensure that the Department thoroughly engages and is accessible to the 22 Arizona Tribes, the Office of Tribal Relations (OTR) has five (5) Tribal Liaisons, one from each division, and a Tribal Relations Manager. The Division of Developmental Disabilities (DDD) and Division of Benefits and Medical Eligibility (DBME) both have a dedicated full-time Tribal Liaison. The Division of Aging and Adult Services (DAAS), Division of Child Support Services (DCSS), and Division of Employment and Rehabilitation Services (DERS) have selected staff to work on Tribal matters on an as needed basis, with no set hours/time dedicated for Tribal support.

The role of the Tribal Liaison is to be the conduit between the Department and each sovereign Tribe; to provide guidance, support, and technical assistance to the Tribes on Divisional programming, as DES has over 40 different programs. In addition to being the connection and point-of-contact for DES with Tribes, the Tribal Liaison assists with identification of issues with DES policy, procedures, and process.

The role of the Tribal Relations Manager is to make certain that the Department is in good standing with the Department's Tribal Government Consultation Policy and that the relationship and partnership with the 22 Sovereign Tribes is consistent and productive through sound and responsible management. Creating effective and efficient program development goals and strategies through data and analysis of program approach is a delicate but necessary responsibility of the position because each of the 22 Tribes are unique and require separate communication to equitably and effectively address their needs. The Tribal Relations Manager works with Department's Leadership team to make sure they are made aware of successes and

challenges in working with the Tribes to create a strong working relationship, and to stay true to the intention of the Tribal Consultation Policy.

The 22 Arizona Tribes:

According to the Arizona Indian Gaming Association, Arizona has more Tribal land area than any other state in the United States. The American Indian population is roughly 296,000 which is four percent of the total Arizona population. The majority of the tribal lands are in the rural corners of Arizona, where services and resources are limited and lacking, making the point for the OTR Team members to drive to these areas to connect and communicate with the Tribes and Tribal communities.

In FY 2019 the DDD Tribal Liaison drove a total of 13,198 miles, visiting each of the 22 Tribes; most of these trips were completed from January to June 2019. This does not include the helicopter ride to the bottom of the Grand Canyon to meet with Havasupai.

Standard of Work for Office of Tribal Relations:

Beginning January 2019, the Tribal Relations Manager began to identify strategies to reorganize the OTR program structure in order to effectively and efficiently meet the needs of the Tribes. Prior to January 2019, the Tribal Liaisons provided DES and divisional information via community outreach, and handled individual cases involving a tribal member that included a complaint, process issue, and/or miscommunication with a DES program. This dual role hindered the data collection of individual cases/complaints and frequency of outreach and communications with Tribes. Because the Tribal Liaison for Outreach and Communication will be on the road visiting and communicating with Tribes, they are unable to address cases/complaints/issues in a timely manner, thus going over the 42-hour resolution timeframe. Therefore, the restructuring is creating a Tribal Liaison for Outreach and Communication, and a Tribal Ombudsman.

To stay in constant communication and contact with the 22 Tribes, the role of the Tribal Liaison for Outreach and Communication will be the face of DES and representative of their respective Division. They will provide division/program information and updates, attend tribal meetings, and provide technical assistance to the Tribes. Their communications between tribes will be relayed back to the Tribal Relations Manager, so that the overall issues or communications can be addressed at an elevated level should the issue need leadership involvement.

The Tribal Ombudsman will handle individual cases that involve tribal members. These cases could be complaints, assistance with program eligibility, navigation of programming for tribal members, and miscommunication with tribal members and staff. The hope is that the Tribal

Ombudsman, just like the general DES Ombudsman's office, will be able to capture data and frequency of complaints/cases to help with process improvements. Funding for five Tribal Ombudsman is not available at this time, therefore the cases, calls, and inquiries are handled via the client advocates under the Ombudsman's Office, who function as the "Tribal Ombudsman" for each Division. All their data and time will be captured in the DES electronic client service database.

1. Identify the challenge(s) encountered by staff in providing services to tribes and/tribal community members.

The DDD Tribal Liaison had difficulty, on some occasions to reserve a State vehicle in time, as many visits were requested within a very short time, leaving little time for preparation. Contracted providers serving tribes and/community members reported a lack of reliable communication devices (internet/phones) to coordinate visits with members as a most common barrier.

2. Identify a memorable highlight or learning experience that could benefit other state agencies.

The most memorable was presenting to the community, whether it was for just one attendee or 30, this approach opened the door for follow-up communications between tribal social services and other agencies to strengthen governmental relationships.

3. Identify Legislative changes that may have an impact on tribes and/or tribal community members.

Transportation certification across agencies was found to be a barrier. Rural areas have transportation agencies that are familiar with the area. However, transportation agencies must bid for the rides as first come first serve. This process has created a lack of knowledgeable drivers; thus, many rides are not completed. Uncompleted medical and non-medical transport creates a possible health concern.

1. Identify the challenge(s) encountered by staff in providing services to tribes and/tribal community members.

The DERS Tribal Liaison continues to find that the quality, distribution, and awareness-level concerning DERS programmatic and service-related information varies significantly from tribe to tribe. Whether the audience is tribal leadership, tribal staff, or the membership of tribal communities, communication is a constant challenge. Contributing factors may include differences in preferred or available communication mediums, geographical and technological barriers, the availability of staff to compile, organize, and present/distribute such information, and turnover within both DES and the tribes which can often disrupt the flow of information.

The DERS Tribal Liaison, who contributed about ten percent of duty time to tribal relations, departed in March 2019. The tribes are currently being served by the Interim DERS Tribal Liaison at approximately 15 to 25 percent commitment of duty time, as available. With the assistance of other DES divisional Tribal Liaisons and the tribes themselves, the Interim DERS Tribal Liaison is working to overcome these challenges through continued communication strategies. The Tribal Liaison for DERS, working only on an as-needed bases on tribal issues and inquiries does not provide a consistent and accessible technical expert and resource that the Tribes can utilize.

2. Identify a memorable highlight or learning experience that could benefit other state agencies.

The DERS Tribal Liaison met with the DERS Reemployment Assistance Administration (RAA) Administrator and RAA Deputy Administrator to address the need for a designated Tribal Veterans Outreach Coordinator and a Statewide Tribal Veterans Reporting Coordinator. Commitment was received from the DERS Deputy Administrator to designate two veteran employees to provide outreach and reporting for tribal veterans being served in Northeastern Arizona. These activities are being reported weekly to the Tribal Relations Manager via the DERS Tribal Scorecard and are also being keyed in the DES client services database to track assistance being provided to tribal members. The DERS Tribal Liaison continues working with the DES Tribal Relations Manager to connect DERS Veterans staff with tribal members statewide who require assistance and services.

The DERS Workforce Innovation Opportunity Act (WIOA) Policy Specialist and the new DERS Workforce Technical Assistance Coordinator provided continued technical assistance to those tribes operating (WIOA) Title I-B Programs on their tribal lands. The Technical Assistance Coordinator presented at the Nineteen Tribal Nations (NTN) Annual Conference, the NTN Training Academy, and at quarterly Management Information System (MIS) meetings, as well as visited reservations to address each tribe's individual WIOA Title I-B technical assistance needs. The Technical Assistance Coordinator attended the quarterly NTN Local Workforce Development Board meetings and the NTN Directors meetings and was available to answer questions related to the WIOA Title I-B Program during the meetings. The DERS Workforce Policy and Support Unit also assisted in scheduling training in the rural areas for the Arizona Job Connection (AJC) System, thus eliminating the need for tribal members to travel to Tucson or Phoenix for the training.

3. Identify Legislative changes that may have an impact on tribes and/or tribal community members. Not applicable.

4. Recommendations from Tribal Representatives:

Arizona's tribal leadership, as a whole, consistently express a desire to be more engaged both with and by their governmental peers, recommending more peer-to-peer involvement by DES leadership in formal meetings and consultations, and reiterating the need to actively include the tribes in the drafting of State policy by which they may be directly affected. Tribal leadership and tribal staff also stress the need for continued and continuously improved communications strategies, to ensure a more balanced and efficient distribution of information to the Tribes of Arizona.

The correct division is not always notified in a timely manner when there are concerns or requests elevated by tribal entities. Having one point of contact for the department assists with this challenge.

The DES Office of Professional Development offers a Cultural Awareness Classroom Training that is available to all employees.

3. Identify Legislative changes that may have an impact on tribes and/or tribal community members.

None identified.

4. Recommendations from Tribal Representatives:

It would be beneficial to review all Data Security Agreements (DSA) and Inter-Governmental Agreements (IGA) help with the tribal entities to ensure compliance and effectiveness. This will assist with the billing inquiries that have been submitted by Tribal TANF programs.

Face-to-Face interactions with Tribal Social Service Program Administrators support the trusting, communicative relationship DBME has with the tribe.
