## TRIBAL CONSULTATION ANNUAL REPORT July 1, 2018 – June 30, 2019

The purpose of the Arizona Department of Real Estate (ADRE) is to serve and protect the public interest through efficient and timely licensure, balanced regulation and proactive education oversight of the real estate profession in the State of Arizona.

Pursuant to A.R.S. Title 32, Chapter 20 and the Administrative Code Title 4, Chapter 28, the ADRE regulates real estate licensees (including residential sales, brokers, companies, property managers, business brokers, and commercial brokers), private cemeteries, and membership camping licensees.

The ADRE also regulates real estate educators and schools, monitoring prelicensing and continuing education courses to ensure the content quality of courses and competence of the instructors, as well as the quality and timeliness of materials being taught. The ADRE oversees the administration of licensing examinations as well as the activities of licensees to ensure compliance with Arizona Revised Statutes and the Commissioner's Rules. Also, within the purview of the Department is the regulation of the sale of subdivided and certain unsubdivided lands, timeshares, condominiums, membership campgrounds, and cemeteries.

The ADRE recognizes that its regulatory authority does not extend into Tribal communities; however, the ADRE is willing to provide information and assistance where appropriate, when requested.
