Tribal Outreach and Activities Annual Report 2019

Agency Overview

The Arizona Department of Forestry and Fire Management (DFFM), in partnership with local, county, state, and federal agencies, protects Arizona's people by: providing coordination and resource response for the suppression and management of wildland fire; delivering education to aid in the prevention of wildland fire; providing information, education, technical assistance, and integrated management strategies through forestry programs; collaborating in forest restoration; and ensuring fire and life safety through regular building inspections, permitting, and plan reviews.

Tribal Contact

DFFM is in constant collaboration with tribal entities during the fire season while engaging in an active fire: the engagement is essential to ensure cultural sensitivity for tribal interests. The grants department continually advertises and advocates for tribes to apply for funding for projects conducting fuels treatments, invasive vegetation treatments, and wildfire assistance grants among other funding opportunities. The State Fire Marshal office is ready to respond to tribal entities and ready to inspect on reservations at their request.

DFFM is in the process of updating our Forest Action Plan for 2020. The agency is operating under the approved 2010 Forest Action Plan; below is a table listing our current goals and objectives for the agency as it pertains to Tribal interaction.

For all projects involving State Trust Land DFFM collaborates with the State Land Department for tribal consultations. The Land Department is the responsible entity for activities taking place on trust land, therefore the Land Department has agreed to take the lead in tribal notifications.
