

5-14-20 ADHS COVID-19 MEMO

Thank you for your continued support and partnership in helping the Arizona Department of Health Services (Department) address COVID-19 in Arizona. In the continuing spirit of transparency and collaboration, the Department would like to inform you of the three most salient COVID-19 issues that the Department is currently addressing:

- Healthcare facilities have been allowed to resume elective surgeries under [Executive Order 2020-32](#) after submitting an attestation to ADHS. As of May 12, 1,409 healthcare providers have attested that they had at least a 14-day supply of PPE required to resume elective surgeries. ADHS continues to answer questions about resumption of PPE and review attestations. FAQs are available here.
- Today, Dr. Christ joined Director Johnson from the Department of Tourism to provide guidance and answer questions from tourism partners about safely operating while protecting patrons and staff.
- To increase access to testing, Dr. Christ issued a standing order today to allow licensed pharmacists to conduct PCR (diagnostic) testing. This will be posted on the ADHS [healthcare provider COVID-19 webpage](#) later this week.
