Pursuant to A.R.S. §41-844, I am advising you that human remains of 244 Native American individuals were reported to the Arizona State Museum between July 1, 2022 and June 30, 2023. The enclosed table provides the Arizona State Museum case number, date of discovery, number of discoveries, type of burial, the archaeological site of discovery, and the claimant tribe to which each individual will be repatriated. Dates of repatriation are determined between the claimant tribe and the archaeological contractor that removed the remains.
