The Hualapai Tribe Demographic Analysis

Introduction

This analysis of the Hualapai Tribe was undertaken for the Planning Department of the Hualapai Tribe by the Arizona Rural Policy Institute (ARPI) in the W.A. Franke College of Business at Northern Arizona University. The ARPI has produced this Demographic Profile for the Hualapai Tribe using the latest information available from the 2010 Census and the 2010 American Community Survey (5-year estimates). This report is provided to Arizona tribes as a product of the EDA Technical Assistance Grant provided to the ARPI at Northern Arizona University.

Although the American Community Survey (ACS) produces population, demographic and housing unit estimates, it is the Census Bureau's Population Estimates Program that produces and disseminates the official estimates of the population for the nation, states, counties, cities and towns and estimates of housing units for states and counties. Therefore, this report incorporates two major data sources: (1) the official 2010 Census, primarily from the SF1 data report to produce data on the population, age, race and ethnicity relative to Hualapai; and, (2) the ACS 5-year estimate data for the period 2006 to 2010, which is annotated in the document as ACS 2010 (5-year estimates). The 2010 ACS 5-year estimates are based on data collected between January 2006 and December 2010. The data were used to analyze household income, poverty rates, employment, language use and household characteristics for the Hualapai Tribe. Only the 5-year estimates are used as the data was provided for small geographic areas, representing the average characteristics over the 5-year period.

The analysis of demographics for the Hualapai Tribe first examines the 2010 Census and then the ACS where data is available. Demographic characteristics are provided at three separate levels – the State of Arizona, Mohave County and the Hualapai Tribe. Comparisons between the State of Arizona and Mohave County should provide useful comparisons of demographic characteristics for the tribe.

Appendix A contains official Census 2010 data and Appendix B contains American Community Survey data (5 Year Estimates) and Appendix C contains the margin of error estimates to be used to calculate the estimates for the American Community Survey data.

Population


The population of the Hualapai Tribe decreased slightly (-1.3%) from 2000 to 2010; data indicate there were 18 fewer tribal members in 2010. This decrease, however, may not truly reflect the actual change in the tribe between the census periods. The SF1 census is considered the official count, and accounts for only the population within the exterior boundaries of the tribal lands. Conversely, both the State (24.6%) and the County (29.1%) grew significantly between the last census in 2000 and 2010, with the rate of population higher in the County (29.1%) than the State (24.6%).

Gender

There are slightly more females (52.8%) than males (47.2%) within the Hualapai Tribe. The percentage of males in the Hualapai Tribe was lower than either the State (49.7%) or the County (50.0%), while females (52.8%) comprised a larger proportion of the population among the Hualapai that either the State (50.3%) or the County (50.0%).

Age

The Hualapai Tribe is dominated by those under 18 years of age. The under-18 year population accounts for 36.9 percent of all tribal members, representing a far larger portion of tribal members than the same age group in the State (25.5%) or Mohave County (19.8%). The fact that more than one-third of the tribe is younger than 18 years of age carries with it some important policy implications. The large portion of younger tribal members influences the provision of health and educational services as well as poverty and workforce issues as well.




Figure 2. Age cohorts for Arizona, Mohave County & the Hualapai Tribe 2010

On the other hand, the tribe has fewer members who are 65 years or older. This age group, those who have retired and are out of the workforce, accounts for only 5.9 percent of tribal members when compared to 13.8 percent for the State and 23.5 percent for the County. These data indicate the overall youthful profile of the tribe. Finally, those age 18 to 64 years account for 57.2 percent of the tribal members, which compares favorably to the State (60.7%) and the County (56.7%). The large number of young tribal members will have an effect on the development of the tribal workforce in the future. See Table 3, and Figure 2.

A population pyramid, also called an age structure diagram, is a graphical illustration that shows the distribution of various age groups in a population (typically that of a country or region of the world), which forms the shape of a pyramid when the population is growing.

The population pyramid below (Figure 3) illustrates the difference between males and females for the 5 year age cohorts in the Hualapai Tribe. The under-18 age cohorts are symmetrical indicating an even number of males and females. The population between 20 and 21 years of age represent a small part of the distribution. At the top of the age pyramid there are more females than males. This is also a demographic reality as women tend to live longer than men. The age pyramid provides an illustrated snapshot of the age/gender structure of tribal members at the time of the 2010 census.

Population Under 18 Years

Children under 18 years of age account for 36.9 percent of all tribal members. Thus, 630 males and 705 female tribal members are under age 18 – representing 38.6 percent of all males and 35.5 percent of all females who are under age 18. More females are under age 5 (40.4%) than males (39.5%), while there are more males (35.0%) than females (32.8%) between the ages of 5 and 10 years. The sex ratio is similar for the 11 to 17 age cohort, where there are relatively equal numbers of males (21.8%) and females (20.8%). See Table 4.

Median Age




Figure 4. Median age in years 2010

The median age (representing the mid-point of the population, where 50% are above and 50% are below) for Hualapai tribal members is 25 years, with males slightly younger at 24 years and females a bit older at 26 years. The median age of tribal members is ten years younger than the State median (36 years of age) and almost half the median age of the much-older County (48 years). This statistic serves once more to emphasize the relatively young age of tribal members. See Figure 4.

Race

Not surprisingly, the majority of Hualapai tribal members identify themselves as American Indian or Alaska Native alone (95%), while the remaining 5 percent are split between white alone, some other race alone, and multi-race persons. This stands in strong contrast to the State which is 73 percent white alone, and the County which is 87 percent white alone. See Table 6.

Ethnicity


In terms of ethnicity, a small percentage (3.8%) of Hualapai tribal members self-identify as Hispanic or Latino. This is lower than the surrounding County where 14.8% identify themselves as Hispanic or Latino and much lower than the State where 29.6 percent identify themselves as Hispanic or Latino. Households

In 2010, there were 362 households on the Hualapai Tribe, with an average household size of 3.6 persons and an average family size of 4.0 persons. The average household size of 3.6 persons is larger than the State average (3.0 persons) and larger than the County average (2.4 persons). The average family size for tribal members (4.0 persons) is also larger than the State (3.0 persons) and (


A "household" is a person or group of people who occupy a housing unit. The "householder" is a person in whose name the housing unit is owned, being bought, or rented. A "family household" consists of a householder and one or more people living together in the same household who are related to the householder by birth, marriage, or adoption — it may also include people unrelated to the householder. If the householder is married and living with his/her spouse, then the household is designated a "married-couple household." The remaining types of family households not maintained by a married couple are designated by the sex of the householder. A "nonfamily household" consists of a person living alone or a householder who shares the home with nonrelatives only, such as with roommates or an unmarried partner.

Family households (63.3%) predominate on the Hualapai reservation, although traditional married couple families are in the minority (26.6%), and appear at lower rates than the State (48.1%) or the County (45.0%). Households headed by a female head of household or single moms account for almost one-third of all (31.6%) households. Female heads of household in the Hualapai Tribe (35.6%) occur at much higher rates that the State (12.4%) or the County (10.4%). More than half (58.2%) of all households are either married couple families (26.6%) or households headed by single mothers (35.6%). Other household structures include non-family households (36.7%) and unmarried partner households (15.2%). See Table 8 and Figure 6.



Unmarried partner households in the Hualapai Tribe (14.9%) occur at about twice the rate of the State (7.8%) or the County (8.6%). Households containing a member over age 65 account for a smaller percentage of the tribal population (15.5%) than similar age cohorts in the State (26.4%) and County (36.4%) populations. Finally, tribal households are more than three times as likely to have households headed by a single mother with their own children under age 18 (17.1%) than the State (7.1%) or the County (5.3%).






In terms of household characteristics only 27.1 percent of all Hualapai households are headed by a householder, much lower than the State where 37.2 percent of households are headed by a householder and the County where 41.2. Spouse-headed households comprise a much larger share of Hualapai tribal households (7.3%) than the State (17.9%) or the County (20.4%). Households containing children comprise almost two-fifths of all households (36.0%), much greater than the State (28.9%) or the County (23.3%). See Table 9 and Figure 8.

Figure 8. Household structure




Family households dominate among Hualapai tribal members (76%), compared to 66 percent for the State and 65 percent for the County. Non-family households account for less than one fourth (24%) of Hualapai tribal member households and more for the State (34%) or County (35%). Husband and wife families account for only one-third (35%) of tribal households, whereas residents of the State (73%) and the County (76%) are more than twice as likely to live in husband and wife households. Households on the Hualapai Tribe are four times more likely to be headed by a female householder (47%) with no husband present, while households headed by single mothers are far less prevalent at the State (12%) or County (10%). Households on the Hualapai Tribe are more likely (54%) to have children under the age of 18 living in the household than the State (34%) or the County (25%). See Table 10 and Figure 9.




Children Under 18 Years Age Living with Grandparent

Children under age 18 are twice as likely to live with grandparents on the Hualapai Tribe (6.6%) than they are at the State level (2.3%) or in the County (2.1%). There are few differences between the proportions of children by age living with grandparents; the only exception is that more children under 3 years of age live with their grandparents (30.7%) in the Hualapai Tribe than at the State or County levels. 
Figure 10. Percentage of children under 18 living with a grandparent householder



Presence of Multigenerational Households

Households on the Hualapai Tribe are three times more likely to be multigenerational (13.5%), than the State (4.9%) and the County (3.7%). The Census defines multigenerational families as family households consisting of more than two generations, such as a householder living with his/her children and grandchildren. Multigenerational family households may be more likely to reside in areas where new immigrants live with their relatives, in areas where housing shortages or high costs force families to double up their living arrangements, or in areas that have relatively high rates of out-of-wedlock childbearing. Household Income




Figure 12. Percentage of household income by range

The median household income for the Hualapai Tribe is \$34,375, less than the County (\$39,785) and the State (\$50,448). Tribal members are more likely to have lower household incomes than either the State or the County. In fact, households are almost twice as likely to have incomes of less the \$20,000 (36%) than is true at the State (17%) or the County (21%) level, although it is closer to the State proportion. Tribal members are half as likely (16%) to have household incomes between \$20,000 and \$40,000 as in the State (22%) or the County (29%). Correspondingly, no tribal households have incomes over \$60,000, compared to much higher percentages at the State (42%) and the County levels (29%). See Table 12 and Figure 12.

Supplemental Income




Figure 13. Supplemental income

Households on the Hualapai Tribe are three times more likely (39%) to receive Food Stamps than are residents of the State (10%) and the County (12%). They also tend to have more public assistance income (4%) than the State at large (2%) and the County (3%). See Table 13 and Figure 13.

Per capita Income on the Hualapai Tribe (\$12,209) is about half that of per capita income for the County (\$21,523) and the State (\$25,680). Correspondingly, median earnings for workers (\$19,609) fall below the County (\$22,472) and far the State (\$29,573). See Table 14


Poverty


Poverty rates on the Hualapai Tribe (41%) are more than twice as high as the State (15%) and the County (16%). More than half (53%) of all children under 18 years of age are considered to be living in poverty, while one-third (32%) of tribal members between 18 and 64 also live in poverty. One-fourth (26%) of tribal members over 65 years of age live in poverty, three times the State (8%) and the County (7%) rates. See Table 15 and Figure 14.

Children in Poverty

The rates of children under 18 years of age living in poverty are three times higher for the tribe (41%) than for the State (15%) or the County (16%). The highest poverty rates for tribal members are recorded for those children between 6 and 17 years of age; fully 30 percent of these school age children are considered to live below the poverty level. Households in Poverty

The Census Bureau uses a set of money income thresholds that vary by family size and composition to determine who is poor. If a family's income is less than the family threshold, then that family and every individual in it, is considered poor. Further the ratio of income to poverty can be used to measure the degree or depth of poverty. The ratio of income to poverty compares a person's income with their poverty threshold, and expresses the comparison as a fraction. For example, a poverty ratio of 1.0 (income at 100% of poverty level) means a person is living right at the poverty line; a ratio of 0.5 (income at 50% of poverty level) would mean that a person is living in a household making only half the income designated as the poverty threshold. The Census Bureau describes those with family incomes below one half of their poverty threshold as being "severely poor." People with incomes at or above their threshold but below 125 percent of their threshold are classified as "near poor."


Two-fifths of all households (41%) on the Hualapai Tribe are classified as "severely poor," with poverty ratios that ranges from below 0.5 to .99. These rates are more than twice those of the State (15%) or the County (16%). A further one percent of tribal members are classified as "near poor" with poverty ratios between 1.00 and 1.24, lower than State (5%) or County (7%) rates. The data indicate that 41 percent of households are below the poverty line, while the remaining 51 percent are located above the poverty line. See Table 17 and Figure 15.

Households Receiving Supplemental Nutrition Assistance Program (SNAP)

More than one-third of all Hualapai households (39.3%) receive assistance from the Supplemental Nutrition Assistance Program (SNAP). This rate is at least four times greater than the State (9.1%) or the County (11.6%). The proportion of elderly, those over 65 years of age, receiving SNAP assistance (10%) is twice as high as the proportion for the same age groups at the State (5%) and County (3%) levels. 
Fertility

APPENDIX C: THE HUALAPAI TRIBE AMERICAN COMMUNITY SURVEY 2010, 5-YEAR ESTIMATES MARGIN OF ERROR ESTIMATES

ACS Margin of Error Estimates

The ACS estimates are based on data from a sample of housing units and people in the population, not the full populations. For this reason, ACS estimates have a degree of uncertainty associated with them, called sampling error. In general, the larger the sample, the smaller the level of sampling error. The ACS calculates standard errors for each estimate produced and publishes the 90 percent confidence level margins of error (the Census Bureau standard). You can be 90 percent confident that the interval within the margin of error from the estimate includes the true value. Users can add and subtract the margin of error value from the interval to find the top and bottom of the range within which the ACS is 90 percent confident in their estimate lies.

Understanding margin of error

A term you will often come across in survey research is "within the margin of error." Most people hear the term frequently during election season when results from polls are reported. Many surveys and polls collect data from a representative sample of a population to make determinations about a larger population. Results would be somewhat different each time the survey is administered to a different representative sample. The margin of error accounts for these differences by calculating an upper and lower boundary the true result would likely fall between if every member of population was surveyed.

For example, in the case of the Hualapai Indian Tribe the ACS has established that there are 178 families represented on the Hualapai Reservation. The survey also indicates that there are 143 family households (families) with a margin of error of plus or minus (±) 12.7 percent and 80.3 percent of the respondents responding indicated that they were in fact family households. The margin of error tells us that if the same survey were administered to the Hualapai Tribal members again, it is highly probable that the percent of "family household" responses would be between 67.6 percent and 93.0 percent, or 80.3 percent ± 12.7 percent.
